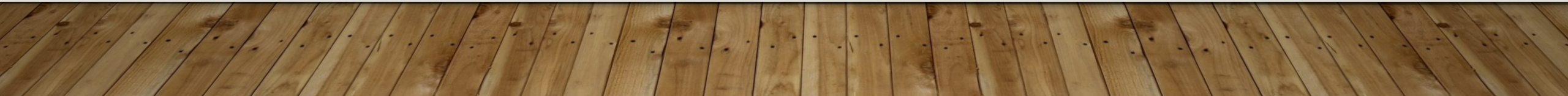

However if these two are not perceived to be done in the time that a personal share holder is deceased then their personal share will be given back to Creation Investors to be distributed as the core Members choose that's best for the company and or corporation.
